Persons interested in inspecting the tires prior to the submission of a bid should contact Chad Grimes at 517-673-4132. FAIRFIELD TOWNSHIP will accept bids until Monday, December 11, 2017 at 5:00 pm. Bids will be reviewed by FAIRFIELD TOWNSHIP Board on Monday, December 11, 2017 at 7:00 pm. Should the FAIRFIELD TOWNSHIP Board elect to accept a bid, FAIRFIELD TOWNSHIP will notify the selected bidder. The bidder will have 7 days after notification that their bid was accepted to provide payment in full. Payment must be made in full before the buyer can pick up. Checks must be payable to Fairfield Township. Only certified or cashier's checks will be accepted. The buyer will be solely responsible for picking the tires up from the township Fire Department. FAIRFIELD TOWNSHIP will require that the respondent with the accepted sign a Release of Liability Form. Questions regarding this request for bids should be directed to FAIRFIELD TOWNSHIP.

The following general conditions are imposed on all proposals submitted in response to this REQUEST FOR BID:

1. Proposed prices represent an offer to contract on the part of the proposing party, and all proposed prices must remain in effect for at least ninety (90) days from the date of receipt of the proposal by FAIRFIELD TOWNSHIP.
2. No bidder may withdraw a proposal after submission of the proposal to FAIRFIELD TOWNSHIP except in case where a bidder demonstrates to FAIRFIELD TOWNSHIP's satisfaction that a material and substantial mistake was made in preparing the proposal, in which event the bidder has 24 hours after receipt of the bid to deliver to FAIRFIELD TOWNSHIP, a notice in writing that he/she desires to withdraw his/her proposal and stating the reasons therefore. Once a proposal is withdrawn, it may not be re-submitted.
3. The successful bidder will be expected to deliver payment in full of the accepted amount to FAIRFIELD TOWNSHIP prior to the granting of authorization by FAIRFIELD TOWNSHIP to proceed with picking up the tires.
4. THESE TIRES ARE SOLD "AS-IS". IT IS THE SOLE RESPONSIBILITY OF THE BIDDER TO INSPECT PRIOR TO SUBMISSION OF ANY BID/OFFER TO FAIRFIELD TOWNSHIP.
